

# FORESTRY & WOOD PRODUCTS IN OREGON

Oregon's wood products industry is a traded sector, with close to 75 percent of all products made here sold outside the state. Oregon dominates U.S. production of softwood lumber and plywood. Now, it's also a leader in engineered wood, and home to the first mill in the United States to manufacture structurally certified cross-laminated timber (CLT). Oregon forest landowners practice sustainable forestry and comply with the Oregon Forest Practices Act.

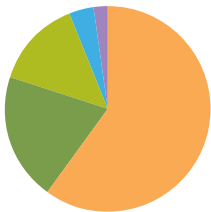

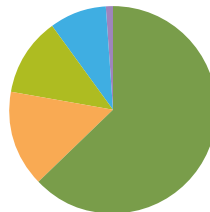

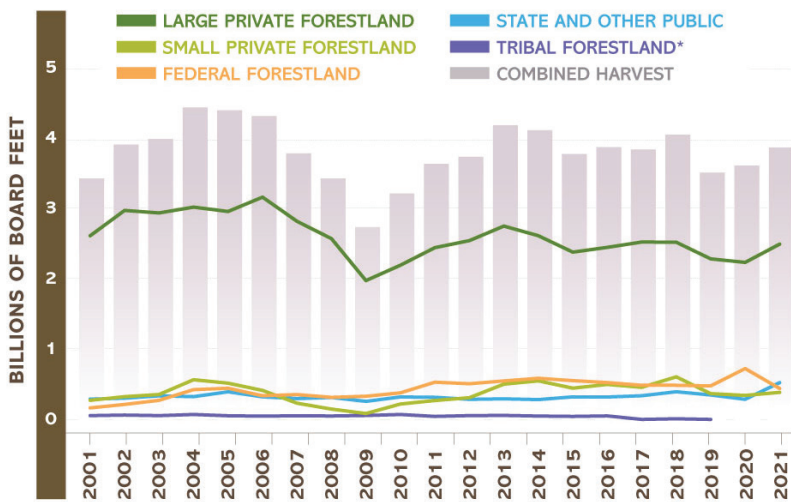

### TIMBER HARVEST BY OWNER



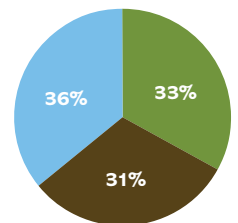

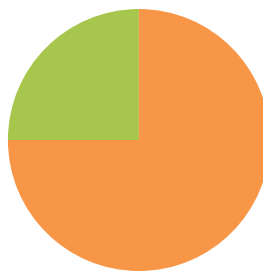
